Gandhi R/o C-56, N.D.S.E Part - II, New Delhi, hereinafter jointly referred to as THE TRUSTEES (which expression shall unless excluded by or repugnant to the context be deemed to include the trustee or trustees for the time being of these presents and their successors in office) of the OTHER PART.

WHEREAS:

- THE SETTLOR is desirous of establishing a TRUST FUND for Public Charitable objects for general public.
- The trustees have agreed to act as the LIFE TRUSTEES.

NOW THIS IDENTURE WITNESSETH AS FOLLOWS

- In order to effectuate the said desire the SETTLOR has made over the TRUSTEES a sum of Rs. 3,000/- (Rupees Three Thousand Only) to hold the same together with all other properties that may acquired out of the same or otherwise and may hereafter be

subject to the TRUST (hereinafter referred to as the TRUST FUND) for the objects and purpose hereinafter expressed with the powers and on the terms and conditions herein contained concerning the same.

2. The name of the Trust shall be Dental & Medical Educational Trust, C-56, N.D.S.E, Part -II, New Delhi.

3. The Head Office of the Trust Fund shall be at Delhi or such other place or places in India as the trustees may from time to time think fit.

4. The objects for which the Trust Fund is established are:

Relief of the poor, education, medical relief, and the advancement of any other object of general public utility not involving the carrying of any activity for profit and for such purposes as:-

- a) To establish & maintain a Dental College Medical College
- b) To establish, maintain, and/or grant aid in cash and/or kind to hospitals, medical schools, medical college, nursing institutions, sanatoriums, charitable and/or travelling dispensaries, after care clinics, maternity homes, and/or child welfare and other institutions of medical relief for general public and to arrange and manage camps for eye diseases and other diseases.
- c) To establish, support, acquire, run and/or grant aid and other financial assistance to schools, colleges, libraries, reading rooms, hostels, boarding houses, laboratories and other institutions of like nature at any place or places in the Indian Union for use of the students and the staff and also generally for the development and/or advancement of education and diffusion of knowledge amongst the public in general.


- d) To establish, maintain and/or run studentships, scholarships and render other kind of aid to individuals including supply of medicines, books stipends, medals and other incentives to study without any distinction of caste, colour or creed.
- e) To grant aid, promote, establish, support and/or maintain music drama and fine arts and for the diffusion of useful knowledge through schools, colleges, laboratories, reading rooms, libraries research and other institutions having the similar objects for the benefit of the public in general.
- f) To establish and/or grant aid and/or assistance in any form for establishment and maintenance of parks, gardens, gymnasiums and sports institutions, tubewells, wells and water works for supply of drinking water, roads and gutters and for the constructions of and/or repairs of the same for the use of public in general.
- g) To establish, maintain and grant aid to homes, orphans or other establishments for relief and help to the poor and destitute people, orphans and widows.
- h) To establish, support, acquire run and/or grant aid and other assistance to institutions imparting various types of vocational training to boys and girls, men and women and generally to establish, support, acquire run and/or grant aid and other maintenance to welfare centers embodying a complex of medical relief, schools, colleges, vocational training centres, libraries, reading rooms, hospitals, laboratories, provisions and the like for the benefit of the public in general.
- i) To establish, maintain, run and/or grant aid and other assistance to building of congregations and/or community halls for the benefit of the masses in general.
- j) To give help for the improvement and protection of animals and birds of all kinds.
- k) To distribute clothing for wear and other apparels for the poor and the needy.
- l) To publish books, monographs, periodicals, journals, review, pamphlets, souvenirs, pertaining to the objects herein mentioned.
- m) To provide help to the destitute, the physical handicapped people and the poor without any distinction of caste, colour or creed.
- n) To grant relief during natural calamities, such as famine, earthquake, flood, fire, pestilence and on such other occasions of calamities of similar nature and to give donations, subscriptions or contributions to institutions, establishments, or persons doing such relief work or persons effected directly.



- o) To render assistance and/or grant aid to recognised public charitable trusts or institutions or individuals.
- p) To give donations to local Government, State Government, Central Government and other agencies for charitable purposes for defence of the country in hour of need.
- q) To donate or contribute to any benevolent and charitable pursuits for the public good in general direct or through similar charitable institutions.
- r) To propagate family planning and offer full co-operation and assistance to all benevolent schemes, health and sanitation, undertaken by the state or central Governments or other philanthropic organisations.
- s) To do any other act for the advancement of general public utility not involving the carrying on of any activity for profit, without distinction of casts, colour or creed.

5) THE TRUSTEES shall cause true and accurate accounts to be kept of all moneys received and of all matters in respect thereof in course of management of trust properties or in relation to the course of management of trust properties or in relation to the carrying out of the objects and purposes of the trust as well as of all assets, credits and effects of the trust properties.

For the furtherance of the objects of the trust the investment of use of trust Funds for the time being in force, the TRUSTEES will have the following powers:-

- a) To accept any donations, contribution, grant or subscription in cash or in kind from any person, body of persons or trust towards the corpus of Trust Fund to meet the objects mentioned herein before.
- b) To apply the whole or part of the income of the Trust Fund of accumulation thereof or whole or part of the corpus of the TRUST FUNDS, for any one or more of the objects of the Trust, as the TRUSTEES may in their discretion from time to time, determine.
- c) To invest or deposit Trust Funds and incomes of the Trust in the forms and modes as prescribed under Income Tax Act and Rules made thereunder;
- d) To borrow or raise or secure payments of money and also to lend money.
- e) To sell, dispose of, alienate or otherwise deal with any property comprising the TRUST FUND.
- f) To let out, demise any immovable property comprised in the TRUST FUND for such period and at such rent, on such terms and conditions as the TRUSTEES in their discretion may think fit.
- g) To open account with any bank, or banks to operate such account and to give instructions to the bank and to provide for opening and operation of such account by the TRUSTEES or by an agent appointed by the TRUSTEES.

- h) To adjust, settle, compromise, compound, refer to arbitration all actions, suits, claims, demands, and proceedings regarding the TRUST FUND.

- i) To appoint constituted Attorney or Agents and to delegate to such attorney or Agents all or any of the power vested in the Trustees under these presents and from time to time remove such Attorneys and Agents and to appoint other in his or their place.
- j) To appoint or make provision for the appointment of any person (including all or any of the TRUSTEES as committee or Administrator of Managing Trustees of Trustees or otherwise) for the purpose of the Trust in such manner and subject to such rules and regulations as the TRUSTEES may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any property or any fund or investments subject to the provisions of this deed in such manner and subject to such rules and regulations as the TRUSTEES may from time to time think fit.
- k) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and of running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- l) To start, abolish discontinue any charity or charitable institutions for the benefit of general public and to impose any condition to any subscription or donation made by them.
- m) To set apart the whole or part of the income or the corpus of trust fund or part of the objects of the 'Trust'.
- n) To join, incorporate or amalgamate this Trust with other or others having similar or allied objects upon such terms and conditions as the Trustees may in their discretion think fit particularly in conformity with the objects and nature of this Trust.
- o) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- p) To transfer all or any part of the property assets, liabilities and engagements of this Trust to any one or more of the Trust, Societies, institutions or associations with which this Trust is authorised to amalgamate.
- q) It shall be lawful for the Trustees of these presents at any time if they so desire to transfer and hand over the Trust Funds in their possession or control to any other Society, corporation, Institution, Trust or Organisation on such terms and conditions as the TRUSTEES shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institution or Organisation.

6. It shall be lawful for the TRUSTEES to give aid by way of donations out of the income of the corpus of the Trust Fund or otherwise to different charitable institutions, societies, organisations or trust to enable such institutions, societies, organisations or trust to start, maintain or carry out charitable objects.

uncontrolled discretion instead of acting personally to employ and pay any agent (including any Bank) to transact or to do any act whatsoever in relation to the Trusts of these presents including the receipt and payment of moneys without being liable for loss and shall be entitled to be allowed and paid all charges and expenses incurred thereby.

8. It shall be lawful for, the Trustees to borrow moneys either on the security of any property comprised in the TRUST FUND or otherwise for all or any of the purposes of these presents and it shall be lawful purposes of these presents and it shall be lawful for the TRUSTEES to make such borrowings on payments of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

9. The TRUSTEES shall be chargeable only for such moneys, stocks, shares and funds and as shall actually come into their hands and a Trustees shall not be answerable or accountable for neglect, default acts of omission of the other trustees nor of any banker or other person with whom the Trust properties of any Securities may have been deposited or kept.

10. The receipt of a person authorised by the TRUSTEES or a resolution of the Board of Trustees, for any money paid or any property transferred or delivered to the TRUSTEES in execution of any of the power thereof or for purchase moneys or any property authorised to be sold shall effectually discharge any person so paying or transferring or delivering.

11. The TRUSTEES will not be entitled to receive any remuneration as TRUSTEES but any reimburse themselves for all expenses actually incurred by them in connection with the Trust on their duties relating thereof.

12. The number of the Trustees shall not be less than two and more than eleven at any time. If the number of the TRUSTEES shall fall below two, the TRUSTEES shall not except for the purpose of filling any vacancy, act so long as the number is below the said minimum.


13. The TRUSTEES for the time being will be at liberty to appoint additional Trust (s) within the number mentioned above for such period or on such terms as to retirement and reappointment as the TRUSTEES for the time being consider proper. If any trustees dies, retires, becomes unfit or incapable to act, the continuing or surviving Trustees will be competent to appoint a Trustee in place of the Trustees so dying, retiring or becoming unfitor incapable to act as aforesaid. A person shall cease to be a Trustee if he is requested to resign by 3/4ths or, as near thereto as possible of the remaining.


14. The Trustee will be at liberty to resign on giving one month's notice of his intention to do so.


15. The Trustee may from time to time frame rules for the conduct and regulation of the meeting of the TRUSTEES,.

c) Resolutions passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under hands of two third of the Trustees shall be as valid and effectual as a resolution duly passed at a meeting of the TRUSTEES.

17. The Trust hereby created shall be irrevocable.

18. It is expressly declared that no part of the TRUST property or income of TRUST FUND shall be applied for any purpose which is not a public charitable purpose and all provisions thereof shall be construed accordingly.

- At least 10 percent of seats in the school will be reserved for the meritorious children of SC/ST and they will not be charged more than the prescribed fee for different classes in schools run by Uttar Pradesh Board of Secondary Education/Basic Education.
- No grant will be sought from the State Government by the institution and if the school is previously recognized by the Board of Secondary Education and the affiliation of

So, from the date of receipt of affiliation with the said examination councils, the recognition from the council and grant from the state government will automatically cease.

(घ) संस्था द्वारा राज्य सरकार से कोई अनुदान नहीं मांगा जाएगा तथा यदि विद्यालय पूर्व में माध्यमिक शिक्षा बोर्ड द्वारा मान्यता प्राप्त है तथा विद्यालय की संबद्धता केन्द्रीय माध्यमिक शिक्षा बोर्ड, नई दिल्ली/भारतीय विद्यालय प्रमाण पत्र परीक्षा परिषद, नई दिल्ली से प्राप्त है। अतः उक्त परीक्षा परिषदों से संबद्धता प्राप्त होने की

तिथि से परिषद से मान्यता तथा राज्य सरकार से अनुदान स्वतः समाप्त हो जाएगा।


(ड) राज्य सरकार द्वारा सहायता प्राप्त शिक्षण संस्थाओं के शिक्षण एवं गैर-शिक्षण कर्मचारियों को संस्था के अनुमन्य वेतनमान एवं अन्य भत्तों से कम वेतनमान एवं अन्य भत्ते नहीं दिए जाएंगे।
